## TERMS AND CONDITIONS

I wish to participate in the Direct Debit program. I have read and agree to the following terms:

1. I hereby authorize Amare Global Holdings, Inc. (hereafter "Company") to create an Amare Brand Partner Account or an Amare Customer Account (as I so designate) and Profile on my behalf and then input all of my banking / checking account information into my Amare Brand Partner Account. In the event I decide to be an Amare Brand Partner, I acknowledge that my Amare Brand Partner Account will be created so that any commissions I earn will go directly into my designated checking account. I also understand that I can request paper checks from the company for commission payments. I understand that fees may be charged to me for paper check issuance by the bank if I decide to receive commissions by paper check. I further understand that I can change how I receive commission payments at any time by contacting Amare Global Holdings Inc. and providing them with written consent to that change.
2. I further authorize Amare Global Holdings Inc. to electronically debit (withdraw) payment from my US bank account for any order that I place. This may be through my Amare Brand Partner Account if my account is set up that way or if not, then via direct withdrawal. Amare Global Holdings Inc is authorized to withdraw payment equal only to the financial amount tied to the product that I order, plus applicable sales tax and shipping and handling or for the amount of the enrollment order and Subscription order(s) I have established.
3. I agree that my bank shall not be obliged to ascertain whether or not notice of any such transfer or reversal notice has been given to me.
4. I accept full responsibility for any overdraft (or increase in existing overdraft) on my/our account which may arise as a result of any such transfer(s).

5. In the event a Direct Debit payment is dishonored for any reason, I agree to pay a \$50.00 USD service fee. I shall indemnify and hold Amare Global Holdings, Inc. harmless for any and all liability that may arise out of Amare Global Holdings, Inc., initiating an electronic payment on my account (except the liability to ship the product as ordered).
6. **I may stop this arrangement at any time for any reason, by so indicating to Amare Global Holdings, Inc. in writing at least 10 days prior to any scheduled Subscription date.** The arrangement ends upon receipt of written notice. If this arrangement is stopped, I will pay for all orders in advance according to the then-current policies. Amare Global Holdings Inc. also reserves the right to cancel this Agreement at any time.
7. By signing in the appropriate place on this Authorization Form, I, the [Brand Partner or Customer]:
- Acknowledge that I understand the terms of this Authorization Form.

**8. RELEASE & INDEMNIFICATION**

The Brand Partner or Customer herein hereby agree to forever release and discharge Amare Global Holdings, Inc (US) or any subsidiary of Amare Global Holdings, Inc., from any losses, claims, damages, action, demands, judgements, costs, charges, attorneys' fees, or other fees and expenses (collectively "Losses") as a result of any actions, or failures to act, on the part of Amare Global Holdings, Inc. under this Authorization. The Brand Partner / Customer identified herein hereby agrees to indemnify and defend Amare Global Holdings, Inc. from and against any claims for Losses as a result of any actions, or failures to act by Amare Global Holdings, Inc. from any third party.
